Dear Mr. Secretary General,

Through a navigational warning issued by the Russian Federation, Norway has been made aware of a planned missile test in the Barents Sea from 6 to 9 November this year. The navigational warning states as follows:

COASTAL WARNING MURMANSK 324 BARENTS SEA

1. MISSILE AND ARTILLERY FIRING 06 TO 09 NOV 0500 TO 1900 UTC IN AREA DANGEROUS TO NAVIGATION BOUNDED BY 71-35.0N 029-02.0E 71-35.0N 030-14.0E 71-15.0N 030-14.0E 71-15.0N 029-02.0E 2. CANCEL THIS MESSAGE 092000 UTC NOV 18

The area in question forms part of an area where Norway has the following Traffic Separation Scheme (TSS) and recommended routes approved by IMO:

TSS OFF SLETTNES

RECOMMENDED ROUTE BETWEEN TSS OFF VARDOE AND TSS OFF SLETTNES RECOMMENDED ROUTE BETWEEN TSS OFF SLETTNES AND TSS OFF NORTH CAPE.

This is an issue beyond our control and due to these circumstances, the Norwegian Coastal Administration has found it necessary to issue two NAVAREA XIX warnings and corresponding coastal warnings where Norway temporarily suspend the use of the TSS and the connecting recommended routes.

Since the General provisions on ship's routing request governments to inform IMO on any changes in routing measure, we hereby inform the Secretary General on the following two NAVAREA XIX warnings that have been issued:
