

RESOLUTION A.118(V)

MARITIME WORLD ADMINISTRATIVE RADIO CONFERENCE

The Assembly,

*Noting* that the International Telecommunication Union convened a Conference to consider and revise as necessary the provisions of the Radio Regulations and of the Additional Radio Regulations pertaining to the maritime mobile service,

*Noting* with satisfaction the preparatory work carried out by the Maritime Safety Committee, which work was intended to assist Member States in giving consideration to those Conference items which have a bearing on safety of life at sea,

*Having examined* the relevant parts of the Reports of the fourteenth and fifteenth sessions of the Maritime Safety Committee (MSC XIV/20, paragraph 48 and MSC XV/22, paragraph 43),

*Requests* the Maritime Safety Committee:

- (a) to examine in due course the results of the Conference in so far as they affect safety of life at sea and the relevant provisions of the International Convention for the Safety of Life at Sea, 1960;
- (b) to recommend further actions which may be required with regard to revising the appropriate parts of the Convention or taking any steps in relation to radiocommunications which may contribute to improving safety at sea.

PREVENTION OF POLLUTION OF THE SEA BY OIL

The Assembly,

*Recalling* its Resolution A.84(IV), recommending governments which had not then accepted the International Convention for the Prevention of Pollution of the Sea by Oil, 1954, and the amendments adopted by the International Conference on Prevention of Pollution of the Sea by Oil, 1962, to do so as a matter of urgency,

*Noting* with satisfaction that all the amendments to the International Convention for the Prevention of Pollution of the Sea by Oil, adopted by the 1962 Conference, have now come into force,

*Mindful* of the serious consequences of pollution of the sea by oil,

*Bearing in mind* the desirability of as many States as possible accepting the said Convention,

*Recommends* that all governments which have not yet accepted the International Convention for the Prevention of Pollution of the Sea by Oil, 1954, as amended in 1962, give urgent consideration to so doing.

#### INTERNATIONAL MARITIME DANGEROUS GOODS CODE

The Assembly,

*Recalling* its Resolution A.81(IV), by which it approved the International Maritime Dangerous Goods Code together with six annexes and requested the Secretary-General to publish, after approval by the Maritime Safety Committee, the three remaining annexes and any amendments to the annexes which do not affect the principles of the Code,

*Noting* with satisfaction that two annexes (Class 2 - Gases and Class 7 - Radioactive Substances) have now been completed and approved by the Maritime Safety Committee (MSC XII/32, paragraph 7),

*Noting* also the amendments to the International Maritime Dangerous Goods Code approved by the Maritime Safety Committee at its fifteenth session (MSC XV/22, paragraph 67 and Annex IX),

*Recommends* that governments which have not yet done so give consideration to the possibility of adopting the International Maritime Dangerous Goods Code together with the annexes so far published so as to obtain harmonization of national regulations and facilitate the international traffic of such goods.
