

## RESOLUTION A.107(IV)

### BROADCASTS FROM STATIONS OUTSIDE TERRITORIAL WATERS

THE ASSEMBLY,

BEARING IN MIND the provisions of Chapter V of the International Convention for the Safety of Life at Sea, 1960,

CONSIDERING

- (a) that the operations of broadcasting stations on board ships outside territorial waters are increasing;
- (b) that such operations are in conflict with the provisions of the Radio Regulations annexed to the International Telecommunication Convention, 1959, and may adversely affect radio communications contributing to the safety of life at sea;
- (c) that an Agreement for the Prevention of Broadcasts transmitted from stations outside Territorial Waters was signed, subject to ratification, by a number of governments at Strasbourg in January 1965,

REQUESTS the Secretary-General to investigate the question of broadcasts from stations outside territorial waters, in conjunction with the International Telecommunication Union and other organizations concerned, and to report to the Assembly through the Maritime Safety Committee.

RESOLUTION A.108 (ES.III)

AMENDMENTS TO CHAPTER II OF THE  
INTERNATIONAL CONVENTION FOR THE  
SAFETY OF LIFE AT SEA, 1960

The Assembly,

*Recognizing* the need to improve the fire protection of ships,

*Noting* Article 16(i) of the Convention on the Inter-Governmental Maritime Consultative Organization, concerning the functions of the Assembly with regard to regulations relating to maritime safety,

*Noting further* that Article IX of the International Convention for the Safety of Life at Sea, 1960, in paragraphs (b), (d), (e), (g) and (h), provides for procedures of amendment involving participation of the Organization,
