**REVIEW OF THE LIST OF NON-GOVERNMENTAL ORGANIZATIONS  
IN CONSULTATIVE STATUS**

THE ASSEMBLY,

NOTING Part XII of the Convention on the Inter-Governmental Maritime Consultative Organization and in particular Article 48 dealing with arrangements for consultation and co-operation with non-governmental organizations,

RECALLING the Rules governing Relationship with Non-Governmental International Organizations and in particular Rule 10 which provides that the Council shall periodically review the list of non-governmental international organizations in consultative status with IMCO and make a report to the Assembly on the continuation of such status,

HAVING CONSIDERED the decision of Council, at its thirty-eighth session, to continue the grant of consultative status to the organizations already enjoying that status,

NOTING in particular the decision of Council to reconsider the matter, if necessary, after the establishment of guidelines on the subject,

#### **STATUTE OF THE JOINT INSPECTION UNIT**

THE ASSEMBLY,

RECALLING its Resolutions A.256(VII) and A.313(VIII) on the Organization's continued participation in the Joint Inspection Unit,

NOTING that the United Nations General Assembly has decided in its Resolution A/RES/31/192 to approve the Statute of the Joint Inspection Unit established with effect from 1 January 1978 and has invited the organizations in the United Nations system to accept the Statute,

DECIDES to accept the Statute of the Joint Inspection Unit,

REQUESTS the Secretary-General to notify this acceptance to the Secretary-General of the United Nations.
